Illuminist Art of War

"War may sometimes be a necessary evil. But no matter how necessary, it is always an evil, never a good. We will not learn how to live together in peace by killing each others children." -Jimmy Carter, Nobel Lecture, Dec. 10, 2002

In a letter to Giuseppe Mazzini dated August 15th, 1871, Albert Pike graphically outlined a blueprint for three planned world wars.

- 1) World War I would weaken, topple and destroy the powerful Czarist government in Russia.
- 2) World War II would pit Great Britain against Germany, destroy Nazism and create the Zionist state of Israel.
- 3) Fueling aggression between the Zionists of Israel and the Arab world that would eventually destroy one another would ignite World War III. Social, political and economic chaos would then force the masses to accept a one world army and one world government ruled by the Illuminati.

As you can see, the first two global wars were initiated precisely how Pike (an American) said it would be. The third initiation was said to take place on September 11th 2012 (this was the Benghazi cover-up). The first initiation began with a loan shark in the 18th century.

During the 18th century on a cobblestone street called Frankfurt-on-the-Main, the Rothschild legacy began. Mayer Amschel Bauer was a goldsmith and a loan shark. He hung a red hexagon shield over his doorway and changed his name from Bauer to Rothschild (Rot – shild means “Red shield” in German). The red hexagram shield is the symbol for the *World Revolutionary Movement* (Satanism). His focus was to associate his family with occultism and Saturn (Ashtoreth worship). The Astor family is another influential Illuminati family.

According to former Satanist, Bill Schnoebelen, “A hexagram must be present to call forth a demon, and it is a very powerful tool to invoke Satan.” The word “Hex,” as “To put a hex on someone,” derived from the word hexagram. It’s found on the United States Seal and it’s commonly found in, and on churches and Masonic

Temples. It's a powerful satanic symbol understood by the Illuminati and high degree Masons. It's known as the Seal of Solomon, but it's also called the Star of David, the Shield of David, or The Magen David. Including Solomon or David's name with regards to a hexagram is blasphemous, because David (King David of David and Goliath, father of King Solomon) was after God's heart, and Solomon was a King blessed by God. The six-pointed star has long been used in magic, occultism, witchcraft, astrology, and has been found at the scene of a number of occult crimes.


According to M. Hirsch Glodberg (in his book "The Jewish Connection,") "The Star of David is not of Jewish origin. The ancient Israelites never used it as their religious symbol" (they used the Menorah or Seven Candlesticks). The six-point star was introduced to King Solomon after he disobeyed God and married an idolatress from Egypt. Solomon's continued idolatry caused the Kingdom of Canaan (now called Israel, which I will call it for reasons of familiarity) to be split in two. The practices he introduced to the nation of Israel eventually forced the House of Israel's exile into the Caucasus, and the House of Judah endured captivity.

The dynasty of the Rothschild family is defined in letters written by a Rothschild brother in 1815. Lord Rothschild, in his book "The Shadow of a Great Man," quotes a letter sent from Davidson on June 24, 1814 to Nathan Rothschild, "As long as a house is like yours, and as long as you work together with your brothers, not a house in the world will be able to compete with you, to cause you harm or to take advantage of you, for together you can undertake and perform more than any house in the world." The closeness of the Rothschild brothers is seen in a letter from Salomon (Salmon) Rothschild to his brother Nathan on Feb. 28, 1815, "We are like the mechanism of a watch, each part is essential." This closeness is further seen through the eighteen marriages made by Mayer Amschel Rothschild's grandchildren. Sixteen of these marriages were contracted between first cousins.

It's no secret that the Rothschild's are satanic worshipers. According to eyewitnesses who were prominent enough to visit one of the British Rothschild homes, "The Rothschild's worship yet another god too, Satan. They set a place for him at their table." The Rothschild's have been Satanists for many generations. They are an important part of the history of the *Star of David*, because they invented it. The blue hexagram is represents Solomon's Seal which is a copy of the red hexagram that represents the *World Revolutionary Movement*. Throughout the Middle Ages Arab Magicians, Cabalist Magicians, Druid witches and Satanists had used this hexagram figure. One of the few ancient uses of the symbol was on the floor of a 1,200 year old Moslem Mosque (found where Tel Aviv is located today). In the 12th century, an Ashkenazic Jew Menahem ben Duji, who thought he was the Messiah, used the magical symbol. Because the Rothschild's were Satanists, they adopted this powerful magic symbol in 1822 for their insignia that would later become the symbol of a new Zionist, Israel. Let's look at this hexagram and define its true meaning.

"Here is the wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six."

-Revelation 13:18



The numbers 6-6-6 is the true meaning behind the hexagram shape, which is raised high as Israel's state flag. Look at the hexagram examples. The numbers 666 are hidden in points and angles.

- 1) There are 6 points
- 2) There are 6 right angles
- 3) There are 6 sides on the central hexagram

Some conspiracy theorists will teach that the secret of the hexagram includes:

- A) 6 Points
- B) 6 angles
- C) Each angle in a equilateral triangle = 60 degrees



In this example you would have to drop the zero to establish a value of 666, so the first example is more accurate.

Let's further examine the hexagram shape. Notice how it is made up of two large triangles. One triangle is upside down, while the other is right side up. If you place the hexagram over a human body as illustrated below, the central portion of the hexagram is where the heart and lungs are located. The upright point of the triangle points to the mind, while the upside down triangle point to the private area of a human.



In life, there is a battle within these two triangles that we must succeed. The two triangles can be deciphered as such:

Upright Triangle = the fruit of a spiritual mind:

Love
Peace
Happiness
Joy
Harmony
Concord
Agreement

Upside down Triangle = the fruit of a hostile mind:

Ego
Lust
Envy
Jealousy
Enmity (Hate)
Strife
Murder
WAR

One cannot balance these two triangles at once. Either his or her mind is hostile, or spiritual. The Rothschild's believe that they can balance both at the same time, by giving to the needy and secretly destroying them at the same time. Later in this Book, I will elaborate on this analogy, by identifying how the Rothschild's became eighty- percent owners of today's Israel under the section titled, "Word War I."

Hegelian Dialectic

In history, scholars tend to give their perception of the "Art of war." Throughout the past three decades I have read copious amounts of literature in history books about the sinister mind of warlords like, Adolf Hitler for

example. Sometimes the history is written as if the writer knew the subject, personally. From elementary schools to university levels of education in the United States, one will never learn the secrets and truth behind war, because war is an Illuminist design, unfit for civilian knowledge. It's a strategy calculated by secret societies with one ultimate goal, the reign of one global superpower.

From 1831 to 1832, William Huntington Russell (founder of the American chapter of Skull and Bones at Yale University) studied in Germany. While in Germany, he was influenced by the young Hegelian movement that was going on at that time. While in Germany, Russell was initiated into a German secret society that was centered on Hegelian thought, and he was commissioned to develop a duplicate institution in the U.S. Russell did just that, and created the Skull and Bones fraternity at Yale University. Inside the windowless building within the inner sanctum of what is referred to as the "Tomb," besides a wall of license plates with the numbers 322 visible on them, you will find an inscription of the word, "WAR." This is the headquarters of Skull and Bones and it is a clear reference to the Hegelian Dialectic. It's an ominous ideology promoting controlled war or chaos that ultimately leads to a predetermined outcome. It administers mind control on society, entire nations or global influence, with its fake and contrived conflict. The Masons call civilians "Goyim," meaning cattle. This is one phrase I agree with because it's very easy to lead societies anywhere you want them to go, or to make them think the way the elite wants them to think, as long as a Hegelian Dialectic is in place, like in the case of 9/11 (which I will discuss in Book-5). This philosophy seems to have influenced several generations, and is involved in every U.S. Presidential Administration since its commencement.

The Fascist (Nazi) movements in Europe, and Communist movements in Russia, were most certainly influenced and developed through Hegelian followers. The agents of Hegelian thought financed both WWI and WWII on both sides.

WWI: Samuel P. Bush (Bonesman, George W. Bush's Great Grandfather) was instrumental in supplying arms to both sides of the war.

WWII: Prescott Bush (George W. Bush's grandfather) was instrumental in financing Hitler, through his leading role in the Union Banking Corporation, which was later seized by the American government, when this treasonous act was later discovered. Below is the tyrant family who helped keep the U.S. in perpetual war.

Hegelian Dialectic Defined

Georg Wilhelm Friedrich Hegel (1770-1831) invented the Hegelian Dialectic. In Germany, he is known as one of the greatest systematic thinkers in the history of Western philosophy. He was one of the creators of German Idealism. According to Hegel, *The Hegelian Dialectic* is made up of three steps.

Step One: Create The Problem

Step Two: Control The Reaction

Step Three: Offer The Solution

In this Book, I will illustrate how these steps were used in a formula for every major war occupied by America.

The Hegelian dialectical formula: A (thesis) versus B (anti-thesis) equals C (synthesis).

For example: If (A) my idea of freedom conflicts with (B) your idea of freedom, then (C) neither of us can be free until everyone agrees to be a slave.

America is a slave to an elite power, but America's propaganda teaches Americans and other nations around the world that we are the most powerful nation on earth. I would disagree. Though we have the most powerful military in the sea (The Navy), "The one who owns the debt owns the people and their land." In this case, German blood controls Europe, America, Asian and foreign countries, and the Goyim of the earth have no clue.

Alice Bailey, the author of "A Treatise On White Magic" (page 412), states that the Hierarchy has a special group which she calls "The Financial Group," controlling all that can be converted into energy, and constituting a dictatorship over all modes of intercourse, commerce and exchange. According to Alice Bailey, the *Financial Group* is the latest group directed by the Hierarchy. In 1836 Zevi Hirsch Kalischer approached Rothschild and proposed Rothschild buy all of Erez Israel. It took several years for the Rothschild's to finally create a new Israel. The Rothschild's have been a primary force behind the creation of Israel, and so it is appropriate that the nation carries their satanic hexagram as the state logo.

The Ultra-orthodox Jews in Israel will not serve in the Israeli army because they know that God was not behind the creation of modern Israel, but rather the rich ungodly apostate Jews. They refuse to serve ungodly ideology. The strategy used by Rothschild to take over Israel and create a new Zionist state will be discussed momentarily.

World War I

Before World War I began, Rothschild along with other banking families including Rockefeller, JP Morgan, and Warburg began a periodic "Fleecing of the Flock" (as they called it), by creating economic booms followed by furthered depressions. This allowed these "Banksters" to buy up thousands of homes and farms for pennies on the dollar. Ultimately, this strategy would aid in their legislation push to create another Central Bank.

By 1891 the bank families planed to cripple the American economy once again, but this time it wasn't considered a conspiracy because it was written in plain English. The American Bankers Association (ABA) was

considered a conspiracy because it was written in plain English. The American Bankers Association (ABA) was told to send out a memo to bankers to create a depression on a certain date three years into the future. According to Congressional record, here's how the memo read:

"On September 1st, 1894, we will not renew our loans under any consideration. On September 1st we will demand our money. We will foreclose and become mortgagees in possession. We can take two-thirds of the farms west of the Mississippi, and thousands of them east of the Mississippi as well, at our own price... Then the farmers will become tenants as in England..."

--1891 American Bankers Association

These depressions could be controlled because America was on the "Gold money standard." Gold is a commodity that is incredibly easy to manipulate because of its scarcity. Rothschild cornered the gold market in earlier years so Americans wanted silver money reinstated to escape the legal hold that Banksters had on gold money.

By 1896 the issue of more silver money had become the central issue in the Presidential campaign. William Jennings Bryan (a senator from Nebraska) was the democratic nominee and ran for President on the "Free Silver Issue." In Chicago, at the Democratic National Convention, Bryan gave an emotional speech entitled, "Crown of Thorns and Cross of Gold." In his dramatic conclusion Bryan said, "We will answer their demand for a gold standard by saying to them: You shall not press down upon the brow of labor this crown of thorns, you shall not crucify mankind upon a cross of gold." This speech won Bryan the democratic nomination, but the Republicans ran in tight circles with the Banksters and favored the gold standard opposed to silver.

Bryan didn't win the Presidency, but his efforts delayed the Banksters for 17 years of their goal of establishing a new privately owned, Central Bank. There will be a depression after 2012, which is currently being orchestrated now by the elite families. Gold prices will go down and the stock market will go up. This will be a classic "False Economy," that will allow the elite to corner the gold market, and in the end, greatly consolidate banks and real estate. It happened in WW1, WW2, and in the "Financial collapse of 2008," and it was all planned this way by the Illuminati (owners of Central Banks).

By the early 1900's the public was very weary of an institution being established like a Central Bank, so JP Morgan quickly reverted to a Hegelian Dialectic strategy.

Step One: Create The Problem

JP Morgan created a mass hysteria to affect public opinion. He published rumors about a prominent bank becoming solvent (bankrupt). Morgan knew that this mass hysteria would affect other banks as well, and it did. In fear of losing their deposits, the public raced to their banks and commenced massive withdrawals. This caused the banks to call in their loans and a domino effect of bankruptcies, foreclosures, and repossessions caused great turmoil in America. A few years later, Fredrick Allen of Life Magazine wrote:

"The Morgan interests took advantage...to precipitate the panic [of 1907] guiding it shrewdly as it progressed."

Step Two: Control The Reaction

Unaware of the fraud that started the panic of 1907, a Congressional investigation began. This investigation was lead by Senator Nelson Aldrich who was an Implant from the bank cartels. He eventually married into the Rothschild family.

Step Three: Offer The Solution

The commission lead by Aldrich recommended a Central Bank should be implemented so a panic like 1907 could never happen again. This was the recommendation needed by the Banksters to initiate their plans of creating a private Central bank, known today as The Federal Reserve.

Attorneys did not write this Central Banking Bill called the Federal Reserve Act. Instead, The Illuminati including all the heavy bank owners flew to a secret location on Jekyll Island off the coast of Georgia. On this island, JP Morgan had an estate and this is where the bankers wrote the Federal Reserve Act in 1910. Once they returned to the U.S., they handed the Act to their puppet and front man, Senator Nelson Aldrich. Aldrich then pushed the bill through congress but they needed a new President who would make it law. So with heavy financial backing by the Illuminati (Banksters), Woodrow Wilson became the republican favorite and would go on to win the Presidency. Wilson sold his soul to the devil. He was promised a definite win (by way of campaign support) in the Presidential race, as long as he agreed to sign the Federal Reserve Act once he was President. Wilson agreed, and became our 28th President. As President, he signed the Federal Reserve Act, and the Illuminati finally got their private Central Bank in America.

Wilson later became depressed by his involvement and he wrote in regret:

"[Our] great industrial nation is controlled by its system of credit. Our system of credit is privately concentrated. The growth of the nation, therefore, and all our activities are in the hands of a few men... who necessarily, by very reason of their own limitations, chill and check and destroy genuine economic freedom.

We have come to be one of the worst ruled, one of the most completely controlled and dominated governments in the civilized world- no government by free opinion, no longer a government by conviction and the vote of the majority, but a government by the opinion and the duress of small groups of dominant men."

Congressman Louis McFadden also weighed in on the regret of the Federal Reserve, stating:

"A world banking system was being set up here...a superstate controlled by international bankers...acting together to enslave the world for their own pleasures. The Fed has usurped the government."

American education teaches that the American Revolutionary War of 1775 was in short, a war to detach America from England. In history books there are several reasons why this war began, but the truth mirrors the creation of the Federal Reserve Act.

There were several colonies set up in America. King George III of England outlawed the interest free independent currency that was being created and used by the American colonies. This forced these newly American to borrow money from the Bank of England with interest. This act immediately put the colonies into debt. Aggravated with King George, Benjamin Franklin wrote:

"The refusal of King George III to allow the colonies to operate an honest money system, which freed the ordinary man from the clutches of the money manipulators was probably the prime cause of the revolution."

-Benjamin Franklin

So like the Federal Reserve Act, King George III wanted to loan money and collect interest on the colonies in efforts to keep them in debt. REMEMBER: Whoever controls the debt, controls the people and their land.

Pre-WWI Illuminist Strategy

Now that the Federal Reserve was in place, it was time to join a war. The Illuminist Art of War is to loan as much money as one can, to a country fighting a war to the point of placing that country into debt that cannot be paid back.

Here are the facts behind WWI that will never be disclosed in an American history book, nor an American documentary.

The Illuminati now owned a Central Bank in America. The public was told that the Federal Reserve System was an "Economic Stabilizer," creating financial stability, and that inflation and economic crisis were a thing of the past. This was a complete lie, and the Illuminati had set another date to push the economy into another depression like the one they planned in 1907. By increasing the money supply by one hundred percent, the Federal Reserve issued loans to local banks and individuals knowing that they would call in the loans after the war.

There were six Illuminist objectives before WWI:

- 1) Create a Central Bank
- 2) Create a war with a planned outcome
- 3) Use money from Central Bank to loan for war purpose

- 4) End war on an Illuminist date and time, which is the number to the Antichrist (11), November 11, at 11:00 a.m. (11:11:11) and create a Zionist state (Israel)
- 5) Call in loans from Central Bank (Federal Reserve)
- 6) Collapse US Economy and monopolize the banking industry

When the Illuminati develop a strategy, they summon their "Little Brothers" (Masons and Bonesmen) to execute, and to become wealthy in the process of execution. While creating an illusion that America didn't want anything to do with WWI, George W. Bush's great grandfather, Samuel P. Bush was called to supply arms to the Germans. He was also instructed to generate firearms for American troops even though we weren't in the war. Meanwhile, President Woodrow Wilson publicly declared, "Neutrality." This is where the Hegelian Dialectic begins, because behind closed doors, the US Administration (as instructed by the Illuminati) was desperately trying to find away into this war, and they did. During Woodrow's Administration, William Jennings Bryan was picked as Secretary of State.

Bryan stated:

"The large banking interests were deeply interested in the World War because of the wide opportunities for large profits."

War is the most lucrative concept for a Central Bank, because it forces the country to borrow even more money from the Federal Reserve, with interest attached.

President Wilson's top advisors and mentor, Colonel Edward House, was an "Illuminati implant," who secretly reported to the Bank Cartel. He was notified by the Illuminati to place America into war. In a declassified documented conversation between Edward House (President Wilson's Advisor) and Sir Edward Grey (Foreign Secretary of England) regarding how to get America into war, Grey asked House:

"What will Americans do if Germans sink an ocean liner with American passengers on board?"


"I believe that a flame of indignation would sweep the United States and that by itself would be sufficient to carry us into war."

So on May 7th 1915 (on the suggestion of Sir Edward Grey), A British Luxury Liner called the RMS Lusitania was torpedoed off the southern coast of Ireland.

On February 4, 1915, the German government declared the seas around the British Isles to be a war zone and that beginning February 18, Allied ships in the area would be sunk without warning. As Lusitania was scheduled to reach Liverpool on March 6, the Admiralty provided Captain Daniel Dow with instructions on how to avoid submarines. With the liner approaching, two destroyers were dispatched to escort Lusitania

into port. Unsure whether the approaching warships were British or German, Dow eluded them and reached Liverpool on his own.

The following month, Lusitania departed for New York on April 17, with Captain William Thomas Turner in command. The Commodore of the Cunard fleet, Turner was an experienced mariner and reached New York on the 24th of April. During this time, several concerned German-American citizens approached the German embassy in an effort to avoid controversy should a U-boat attack the liner. Taking their concerns to heart, the embassy placed ads in fifty American newspapers on April 22nd warning that neutral travelers aboard British-flagged vessels in route to the war zone sailed at their own risk. The Lusitania had cargo that did not belong on a cruise liner. It included 600 tons of pyroxyline (commonly called gun cotton,) six million rounds of ammunition, 1,248 cases of shrapnel shells (which may not have included explosive charges), plus an unknown quantity of munitions that completely filled the holds on the lowest deck the trunk ways and passageways of F deck.



The German embassy in Washington was well aware of the nature of the cargo being loaded aboard the Lusitania and filed a formal complaint to the United States government, because almost all of it was in direct violation of international neutrality treaties. The response was a flat denial of any knowledge of such cargo. Seeing that the Wilson Administration was tacitly approving the shipment, the German embassy made one final effort to avert disaster. It placed an ad in fifty East Coast newspapers, including those in New York City, warning Americans not to take passage on the Lusitania. The ad was prepaid and a request was made to place the ad on the paper's "Travel page," a full week before the sailing date. Of the fifty newspapers, only the *Des Moines Register* carried the ad on the requested date. This German warning caused some agitation in the press and concern among the ship's passengers. Stating that the ship's speed made it nearly invulnerable to attack, Turner and his officers worked to calm those aboard. Sailing on May 1st as scheduled, Lusitania departed Pier 54 and began its return voyage. While the liner was crossing the Atlantic, U-20, commanded by Captain Lieutenant Walther Schwieger, was

operating off the west and south coasts of Ireland. Between May 5th and 6th, Schwieger sank three merchant vessels. His activity led the Admiralty (the British government department of the Navy), who was tracking his movements via intercepts, to issue submarine warnings for the south coast of Ireland. Turner received this message twice on May 6th and took several precautions including closing watertight doors, swinging out the lifeboats, doubling the lookouts, and

blacking out the ship. Trusting the ship's speed, he did not begin following a zi-zag course as recommended by the Admiralty. Upon receiving another warning around 11:00AM on May 7th, he turned northeast towards the coast, not believing that submarines would likely stay in the open sea.

Possessing only three torpedoes and low on fuel, Schwieger had decided to return to base when a vessel was spotted around 1:00 PM. Diving, U-20 moved to investigate. Encountering fog, Turner slowed to 18 knots as the liner steered for Queenstown (Cobh), Ireland. As Lusitania crossed his bow, Schwieger opened fire at 2:10 PM. His torpedo hit the liner below the bridge on the starboard side. A second explosion in the starboard bow quickly followed. While many theories have been put forward, the second was most likely caused by an internal steam explosion.

After sending an SOS, Turner tried steering the ship towards the coast with the goal of beaching the ship, but the steering failed to respond. Listing at 15 degrees, the engines pushed the ship forward, driving more water into the hull. Six minutes after the hit, the bow slipped under the water, which stopped efforts to launch the lifeboats. As chaos swept the liner's decks, many lifeboats were lost due to the ship's speed. Around 2:28 PM, eighteen minutes after the torpedo hit, Lusitania sank approximately eight miles off the Old Head of Kinsale. 1,198 souls were lost, and 761 survived.

J.P. Morgan owned the ammunition cargo, and by illegally placing it on the Lusitania and leaking this cargo to the German, this guaranteed that the Germans would sink this ship. The Germans were manipulated by the Bank Cartels and had no idea of their true motivation.

Here are the Hegelian Dialectic Steps for America's entry to WWI:

Step One: Create The Problem

Deliberately send an ocean cruise liner with American passengers into German hostile waters to be torpedoed.

Step Two: Control The Reaction

Create propaganda that allures Americans to imagine 1200 Americans dead, when in actuality, of the 1,198 deceased, only 128 Americans died on the Lusitania.

Step Three: Offer The Solution

GOTO WAR!

The First World War caused 323,000 American deaths. J.D. Rockefeller made \$200 Million in 1919 from the war. This would be equivalent to \$3 Billion dollars, today in 2012. The war cost \$30 Billion dollars for America, most of which was borrowed from the Federal Reserve Bank at interest, furthering the profits of the Illuminati (International Bankers). Then in 1920 (after the war ended) the FED called in mass percentage of the outstanding money supply, which created a duplicate panic of 1907. Once again bankruptcy and collapse occurred. Over 5,400 competitive banks outside of the Federal system, collapsed. This created a monopoly for the international bankers.

Initiation of WWI

According to historian Webster Tarpley, King Edward VII was in debt with the Rothschild family and was

directly responsible for World War One.

Edward didn't become king until 1901 when he was 60 years old. As Prince of Wales, he was estranged from his mother, and was kept on a conservative allowance that eventually him deeply into debt. He allowed a several Jewish bankers to manage his personal finances. These bankers included Baron von Hirsch and Sir Ernest Cassell. "Edward also cultivated the Rothschild and Sassoon families. In short, Edward's personal household finance agency was identical with the leading lights of turn-of-the-century Zionism."

In 1908, there was no media or public announcements of a World War. It was completely planned by the Illuminati. They were ready, able, and willing to take the U.S. into this pre-planned, manipulated war.

As mentioned earlier in this Book, the International Bankers managed to have the *Federal Reserve Act* passed which handed over the Central Bank to the banking families in 1913. Some of the owners included the Rothschild's, Rockefeller's, the Morgan's, and the Warburg's. This meant that these families could now control the money supply of the United States.

In the year 1913, a small group of Masons were entrusted with the task of shaping the opinion of British public in favor of a war with Germany. The money used to allow the British to go into war came from Lord Rothschild and the Rockefeller's. This group included Arnold Toynbee, Walter Lippmann and Edward Bernays, a nephew of Sigmund Freud. This was an easy task for the banking families because they owned the media and newspapers.

Engdahl writes: "One of the best kept secrets of the years 1914-1918 World War, was that on the eve of August 1914, when Britain declared war against the Third Reich, the British Treasury and the finances of the British Empire were in effect bankrupt." The banking families had everything and could coerce the government. We are never taught that the murderers of Archduke Ferdinand of Austria were freemasons. The Austro-Hungarian authorities immediately made 30 demands from Serbia of which 29 were accepted the same day. Yet, within 24 hours, war was declared.

Author Charles Callan Tansill, in his book *America Goes To War*, writes: "Even before the actual clash of arms, the French firm of Rothschild Freres cabled to Morgan and Company in New York suggesting the floatation of a loan of \$100 million, a substantial part of which was to be left in the United States to pay for French purchases of American goods." The Morgan's were also chosen as the sole agent for the purchase of goods for Britain during the war.

According to Congressional records of 1917: "In March 1915, the J.P. Morgan interests...got together 12 men high up in the newspaper world and employed them to select the most influential newspapers in the United States and the sufficient number of them to control generally the policy of the daily press...They found it was only necessary to purchase the control of 25 of the greatest papers."

The reason for buying control of US media was to move public opinion against Germany and in favor of American entry into the war. Had Germany won, the bankers would not have been able to recover their loans. Woodrow Wilson was re-elected in 1916 on the slogan that he had kept, and would keep, the U.S. out of the war. This was a lie. He had, eight months before the election, authorized his Advisor (House) to sign a secret agreement to take the U.S. into war on the allied side. The text of this agreement was leaked after the war, but Americans did not seem to react to this.

WWI was pre-planned and totally manipulated by the Banking Families, and President Wilson was told to simply obey. A delegation was sent to Wilson that told him that unless the U.S. went to war, the loans given

by the Morgan Bank to the British and French could not be recovered. Rothschild knew the British would not be able to pay back their loans because they were bankrupt. Rothschild wasn't worried about money; he wanted Israel as planned by Albert Pike in the late 1800's. No American President, with the exception of John F. Kennedy (JFK), has defied the bankers in the last 100 years, because if one defies them, they become a target for assassinated or "Suicided," (meaning assassinated but orchestrated to look like a suicide).

The penetration of the banking families into WWI was quite obvious. Max Warburg was head of German intelligence. His brother (Paul Warburg) was a naturalized US citizen. Paul was present at Jekyll Island during the creation of Federal Reserve scheme. The Warburg's were among the owners of the Federal Reserve. Both represented their respective "Countries" in the delegations that met at the "Peace" negotiations at Versailles, during end of the First War.

At one point, Germany wanted to end the war because they were running short on food supplies in 1915. The Illuminati was making "Hand over fist," and proposed to prolong the war by setting up a Belgian Relief Commission. This relief commission was created to quickly cover food supplies to the German army.

A British nurse (Edith Cavell) found out about the madness of this strategy performed by the International Bankers, and wrote a letter that appeared in the *Nursing Mirror* on April 15, 1915. Her Letter indicated that all supplies under "Belgian Relief" that were being sent to Germany was being financed by some American Bankers.

Eustace Mullins writes: "William Wiseman, head of British Intelligence, and partner of Kuhn-Loeb Company, feared that the continuance of the war was at stake and secretly notified the Germans that Miss Cavell must be executed."

Nurse Cavell was arrested and charged with aiding prisoners to escape (Which was fabricated), and even though this crime carried a punishment of a three-month imprisonment, she was executed in accordance with the desire of the International Bankers. This helped prolong the war for another three years, making billions for the Bankers.

Creating a Zionist Israel

As mentioned on the first page of this Book, a letter sent to Illuminati leader, Giuseppe Mazzini, dated August 15th, 1871 from Albert Pike, graphically outlined a blueprint for three planned world wars.

- 1) WWI would weaken, topple and destroy the powerful Czarist government in Russia, which it did.
 - A) By 1916 the Germans had won the First World War as orchestrated, without a single shot being fired on German soil.
 - B) British Convoys were blown out of the Atlantic by German subs. The French Army mutinied, and the Russian Army defected.
 - C) Rothschild offered British Prime Minister, Lloyd George, American backing as Allies for the land of Palestine in return. The British Prime Minister Agreed.

On November 2, 1917, the British Government wrote The Balfour Declaration. It was addressed to Lord Lionel Rothschild. This declaration promised Palestine and Israel to the Rothschild Zionist.

The British did not own Israel or Palestine land. There were Turkish troops there during the war, so the British parachuted tons of free opium and hashish to the Turkish troops (to keep their mind off the war), and then the British stole Palestine from them.

The Zionist Jews were now promised a national home according to *The Declaration of Balfour*, (which was said to be endorsed by President Wilson and the League of Nations). This made Palestine a British mandate, but the Rothschild's wasted no time presenting their Balfour Declaration at the British Government, and reminding them of their written promise to give them Palestine. The British Government complied.

During WWI over 66 million men from 21 countries went into battle. There were over 37 million casualties, including the seven million who died. The Banking

Families thrive on bloodshed and war. As long as the Bankers could create great bloodshed, their monetary and political gains became limitless. This was the financial beginning of creating global dictatorship under their control. Now it was time to plan WWII, as noted by Albert Pike, and create a Zionist State of Israel.

World War II

At the end of the war in 1919, the Treaty of Versailles meetings included Rothschild connected men like Paul and Max Warburg, John Foster Dulles (of Kuhn-Loeb), Colonel House, Thomas Lamont (of Morgans) and Allen Dulles (of Kuhn-Loeb), who were all in attendance. The harsh terms of the Treaty of Versailles set the stage for World War II. One delegate stated: "This is no peace; this is only a truce for twenty years."

He was absolutely right. Twenty years later in 1939, the Second World War started. Prescott Bush was instrumental in financing Hitler, through his leading role in the Union Banking Corporation, which was later

seized by the American government, when his motivation was later discovered. President Roosevelt was told to pardon Bush for his crimes and Prescott was pardoned. This is the power of the elite secret societies.

Another product of the Versailles meetings was the elite's Charter for the League of Nations. This was the Illuminati's first attempt at creating a global institution, but it failed. There needed to be "A meeting of the minds," and there needed to be a special interest organization conception that could promote, New World Order. There also needed to be a creation of the Foreign Relations Institutions (the CFR., RIIA, etc.).

Before illustrating the puppetry of Adolf Hitler, with strings attached to the hands of the Illuminati, I must first reveal a Jewish secret that I discussed from Book-1. The Secret is:

The reason the Rothschild's claim to be Jewish is because the Khazars under the instruction of the King Bulan, converted to the Jewish faith in 740 A.D., but that did not include converting their Asiatic Mongolian genes to the genes of the Jewish people. In a map from the Jewish Encyclopedia [Reproduced in the book form of this tract, "Facts are Facts"] the territory of the Khazar Kingdom in the 10th century was still by far the largest of any nation in Europe. The population of the Khazar Kingdom was made up for the most part of

Khazars with the addition of the remnants of the populations of the 25 peaceful agricultural nations, which had inhabited this approximately 1,000,000 square miles before their conquest, by the invading Khazars. In the 1st century B.C. the Khazars had invaded Eastern Europe from their homeland in Asia. The Khazars invaded Eastern Europe via the land route between the north end of the Caspian Sea and the south end of the Ural Mountains.

The Khazars were not "Semites." They were an Asiatic Mongoloid nation. Modern anthropologists as Turco-Finns classify them racially, as they were a very warlike nation. The




Khazars were driven out of Asia finally by the nations in Asia with who they were continually at war. The Khazars invaded Eastern Europe to escape further defeats in Asia. They did not find it difficult to conquer the 25 peaceful agricultural nations occupying approximately one million square miles in Eastern Europe. In a short period, the Khazars established the largest and most powerful and wealthiest kingdom in Europe.

The Khazars were a pagan (satanic) nation when they invaded Eastern Europe. Their religious worship was a mixture of phallic worship and other forms of idolatrous worship practiced in Asia by pagan nations. This form of worship continued until the 7th century. 


As slaves of the Egyptians, child labor was common among the Israelites. The boy shown to the right is about 15 years old. Unlike Egyptian boys, this Hebrew boy eventually grew a full beard.

Above, These Israelite children are about 10 years old. They worked in the fields of the Egyptians, as their parents labored in the brick pits seen at the top of the page. Their days off depended on which of the many Egyptian deities their master worshipped.

There were two shades of color that made up Israelites. There were light skinned Shemites as seen to the right, and the dark skinned Nubians seen at the bottom. The Nubians were from Southern Hamites. The name Hamite came from Noah's son's name, which was Ham. The Rulers of the Earth looked like the Nubians below, after the Great Deluge (floods).



On the *History Channel*, in history books, or on documentaries, you may have seen the top half of the glyphs seen below. History normally does not show the man bowing at the bottom.


The reason is because all that was created by the hands of that man bowing was taken away, and his history changed.

5. **UGANDA** - A line of 33 Kings traced their lineage to King David (father of King Solomon). This is a Uganda tradition.

6. **LIBYA** - 640 C.E.: Israelite Queen Diah Cahena organizes an army to defend against Roman and Arab incursions into North Africa.
7. **KAZEMBE** - 1831 C.E.: Shemitic Africans who's King wore the Mitre Head-wrap resembling that of the Israelite High Priest.
8. **MARRAKESH** - 1000 C.E. to 1500 C.E.: Hebrews allowed to practice the Torah. This was now the Islamic period.
9. **TANGIER** - 1150 C.E.: Israelite sanctuary established by Beni Moussa. These were sons of Moses.
10. **KAMNURIA** - Medieval Hebrew State north of Senegal river.
11. **GHANA** - 300 C.E.: Hebrew dynasty established by Za El Yemeni , lasts about 1,000 years. It became known as the Songhay Empire.







The safety of the Great Port and fleets at Perl Harbor fell on two men, Major General Walter C. Short and four-star General, Husband E. Kimmel. The public was furious over this attack, so the government used these two men as scapegoats to draw away the attention of what had really taken place.

In a declassified letter from retired Colonel Carlton G. Ketchum, written in Pittsburg January 1980, Ketchum writes:

"Dear Sir, Early in 1942, only months after Perl Harbor, I was invited by Congressman George Bender of Ohio, to attend a special meeting of a select group of congressmen and government officials at the Army and Navy Club in Washington. This was an informal group that met biweekly to dine, talk freely on matters otherwise held confidential, and play poker. One of the groups member was the head of the F.B.I., J Edger Hoover, who said from early fall of 1941 until a few days before the Japanese attacked, they had had warning that it was coming. Much more important, President Roosevelt had had warnings during all of that time from a number of sources. But he was very sure they were not passed onto General Marshal, nor General Short, nor Admiral Kimmel, the Commanders in the Pacific. Hoover said the President told him not to mention to anyone, any of this information, but leave it to be handled in his own judgment. Yours faithfully, Carlton G. Ketchum, U.S. Army Air force, Retired."

The Americans and British knew about the attack of Perl Harbor far before the attack happened. Perl Harbor was a blood sacrifice by the Illuminati in order to have an excuse to test the H-Bomb and the A-Bomb. Like the newspaper warning before the Lusitania was sank by the Germans, Perl Harbor was also warned by newspapers a week before the attack.

According to Jerome F. Winzig's written column in the Northern City Journal (August 14, 2000 issue), The United States began monitoring Japanese military communications in the 1920s. By 1940 they had already deciphered all the codes used by Japan throughout World War II (Japan never discovered that its codes had been compromised). Before the attack on Pearl Harbor, thousands of Japanese military radio messages were intercepted and decoded by U.S., British, and Dutch intelligence operations. President Roosevelt not only knew about the Pearl Harbor attack in advance, but intentionally set about to provoke it and deliberately positioned American ships in Hawaii so they could be attacked.



The Fascist Plot on America

Franklin D. Roosevelt (FDR) was a Rothschild puppet like most U.S. Presidents with the exception of JFK. Though a puppet, FDR was seen as a traitor amongst Wall Street and the banking cartel. Far before the attack on Pearl Harbor, another attack was being planned to assassinate President Roosevelt. The Elite saw Roosevelt as an enemy, and not "One" with their ideology of controlling the world.

In an article titled, "Wall Street Backed The Plot To Kill FDR," found in the Executive Intelligence Review (October 21, 2011) Anton Chaitkin researches the facts behind this assassination plot. The article states that Prescott Bush was a managing partner of Brown Brothers. Harriman and E. Roland Harriman were chairman of Union, which represented the interests of the German Thyssen family in the United States.

A U.S. government investigation showed that Union was heavily interlocked with Thyssen's German Steel Trust, which produced a substantial portion of Nazi Germany's steel and explosives. Wall Street banker Clarence Dillon, of Dillon Read, had organized the Steel Trust, Germany's largest industrial corporation, in 1926. Dillon was a friend of Prescott Bush's father, Sam Bush. The majority owner of the Steel Trust was Fritz Thyssen, a prime sponsor of Hitler.

On Jan. 22, 1932, Roosevelt announced his candidacy for the Democratic Party Presidential nomination. The convention was scheduled for late June in Chicago. From the very beginning, FDR was by far the favorite to win the nomination and the Presidency. However, the Morgan interests that owned the Democratic Party, through party chairman John Jakob Raskob and Executive Director Jouett Shouse, had other plans. They launched a "Stop Roosevelt" operation, employing a number of Morgan members, and drawing upon party factions that had their own differences with FDR.

Morgan's puppet, Al Smith, the governor of New York, announced his candidacy on Feb. 6th 1932, creating a serious split in the New York Democratic Party. In the wake of FDR's landslide victory over Herbert Hoover in the November 1932 general elections, the Morgan and City of London financier faction quickly regrouped. If they could not defeat Roosevelt by the manipulation of the ballot, they would use other deadly means.

On Feb. 15, 1933, less than a month before Roosevelt's March 4th inauguration as President, a "Lone assassin" attempted to kill FDR, during a rally in Miami, Florida. Giuseppe Zangara, an Italian immigrant and unemployed laborer, fired at the podium, just as Roosevelt was shaking hands with Chicago Mayor, Anton Cermak. Cermak was shot, and died several weeks later. While investigations into the shooting never developed evidence of a broader plot, interrogations of Zangara confirmed that he had intended to kill FDR.

Starting in early 1933, leading operatives of the DuPonts, the Morgans, and the DuPont/Morgan-controlled General Motors, including the recently deposed Democratic Party honchos Raskob and Shouse, conspired to organize a military coup d'état against the President, claiming that Roosevelt was a "Jew communist," who would destroy the United States through *New Deal* hyperinflation.

Conspirators first contacted Major General Smedley Darlington Butler (USMC-ret.) in July 1933, in an effort to recruit him to the plot. As he reported later to the McCormack-Dickstein Committee of the House of Representatives, they asked him to recruit an army of 500,000 World War I veterans to march on Washington and force Roosevelt's resignation, then to impose a regime modeled on those of Mussolini and Hitler.

In September 1934, the plotters established the American Liberty League, with Al Smith, Raskob, and

Morgan lawyer John W. Davis joining the ranks of the Grayson Mallet-Prevost Murphy, Pew, Pitcairn, Rockefeller, and Lamont's interests. To set the stage for the pro-fascist bankers putsch, Henry Luce's Fortune magazine devoted its July 1934 issue to praise Mussolini. Anglophile editor Laird Goldsborough penned a signed editorial, which proclaimed, "Fascism is achieving in a few years or decades such a conquest of the spirit of man as Christianity achieved only in ten centuries"

General Butler told Congress that he had been repeatedly approached by one of the Morgan operatives, Gerald MacGuire, who had spent seven months in Europe, at the start of 1934, making contacts with leading Synarchists (Freemasonic sect) in Italy, France, and Germany.


Hesitant to signal that the Morgan Group was plotting a fascist takeover of America, MacGuire told Butler that the new movement was to save America from FDR, and was modeled on the French secret military organization, Croix de Feu (Fiery Cross), which was a lie. It was in fact America's Veterans of *Foreign Wars* or *American Legion*. The Croix de Feu was a hard-core pro-Fascist, pro-Nazi apparatus, which had failed in coup plots in France, and ultimately became part of the collaborationist Vichy regime.

Butler became suspicious and took his story to the news media and Congress, resulting in a tremendous scandal. Working with Philadelphia Record journalist Paul Comley French, Butler substantiated every detail of the plot. In one meeting with French, MacGuire openly declared, "We need a fascist government to save the nation from the Communists." He explicitly endorsed Hitler's forced labor camps as the "Solution" to unemployment in America.

Morgan was essentially a British bank, having begun as the New York branch of J.S. Morgan & Co. of London, a bank with close ties to the Venetian Rothschild banking interests. With a steady supply of European money, Morgan had led the fight to bankrupt the American System entrepreneurs and take over their operations. In this way, Morgan monopolized railroads and industrial interests, combining them into trusts like U.S. Steel and General Motors. The Morgan partners viewed themselves as International Bankers, above the laws of mere nations. They were not the only ones who did so, but they were the most powerful of the American branch.

J.P. Morgan was instrumental in the plot to overthrow FDR in 1934. While the treasonous plotters were never prosecuted for their crime, for political reasons, the ramifications of their actions were not overlooked, and the Administration set out to break their power.

One way this was done was by passing the *Glass Steagall Act*, which prohibited commercial banks from engaging in the securities business. This Act forced the Morgan bank to split into two separate companies, the commercial bank J.P. Morgan and the investment bank Morgan Stanley.
